Highway operative and Parish Council meeting
Last month I arranged a meeting with local large hauliers, agricultural business and my parish councils. We exchange the projects, problems and issues faced by business and residents living in our rural communities and the impact on our highways. Kingspan and the Quarry being large companies have some control over their sub-contractors and wish to be informed of bad practice. In addition to the tachographs which all HGVs must have many of the new vehicles also now have cameras in the cab which can also further check on the driver. I continue to work with our Balfour steward and my Parish Councils on maintenance issues and I enclose the website connections for reporting and information.

Ash die back
Everyone must have heard of the disease called Ash die back that is sweeping the country. There are several thousands of Ash trees in my parishes and the Forestry commission indicate that most trees will die. I have been alerted that if killed they will become dangerous including threatening buildings, highways or overhead cables. It is the responsibility of the owners to remove them. Check your insurance cover and the best defence is to remove a disease Ash trees quickly.
New Waste Transfer Site in Kington
The new Household Recycling Centre situated on Old Eardisley Road, will open on Saturday 9 April 2016.

The Household Recycling Centre will help residents recycle and divert more materials from landfill including items such as rubble, cardboard, wood, metal and electrical goods (TVs, monitors, fridges and freezers). The split-level site will also allow easier access for customers; removing the need to climb steps to access the recycling skips and for HGVs servicing the site. The new site will be open three days a week (Friday, Saturday and Sunday 8 am to 6 pm) the HRC would be able to recycle up to 2,000 tonnes each year. The rules on commercial vehicles not entering the site apply to Kington as they do at Leominster.

Waste material accepted

Re-usable item container – including bicycles

Batteries; books/CD/DVD; cans; car batteries; cardboard; chemicals (including non-toxic paints); clothes/textiles; engine oil; Fluorescent tubes; foil; fridges and freezers; garden waste; glass bottles; low energy light bulbs; LPG containers; mobile phones; paper; plastic bottles; ink jet printer cartridges; scrap metal; soil and rubble; televisions; tyres; small electrical appliances; wood; general waste (including water based paints)

Material not accepted

Asbestos; cooking oil; plasterboard; printer toner cartridges.

- 7.1 No Lengthsman work in March. Drive-round on Tuesday 26 March identified defects as on tabled document.
- 7.3 Eardisland in Bloom – The team have managed to work each Thursday over the last month, with volunteers working on different projects. These include refurbishing the boat, weeding most of the gardens and starting to create a new garden along the front of the Manor House wall. The latter will take a number of weeks if not months to complete but should eventually give even more colour to the centre of the village. The annual Plant Sale will take place in the village hall on 14th May.
- 7.4 Play Area – Weekly inspections continue to show no faults.
- 7.6 Although the Clerk has the list of threshold levels, which are given in metres above ordnance datum (AOD is sea level at Newlynne, Cornwall), to relate an individual level to a useful marker we need to know the AOD for various points in the parish – the river, the main road by The Swan, the entrance to School Lane etc. If we mark up a plan with where we want the levels Parsons Brinkerhoff could extract the flood levels for the different events and provide them in a table. They suggest they also provide a plan indicating the general flow direction which may help to determine which is the most relevant level to use for each property. But this would be about 2 days work, including project admin, therefore the charge would be around £900 (exc VAT).
- 7.8 Email to Balfour Beatty from PC – The pooling that is now occurring outside Swandrift is the direct result of the resurfacing undertaken in 2014 by Balfour Beatty or its subcontractor. Therefore what is required is not new work but correction of a situation caused by work undertaken. It does not seem acceptable that any corrective work must now wait until 2017-18, especially given that this issue was first drawn to the attention of Balfour Beatty in November 2014, within about a month of the resurfacing being done!
Email to PC from Balfour Beatty – I appreciate the remarks that have been made. We have a list of defects county wide, with Parish Councils voicing similar requests. We rank the schemes on the basis of risk. The issue is not driven by defective workmanship, instead it has arisen due to the use of a non permeable paving layer installed to a modern specification

- 7.9 Work on redoing the website continues, the Clerk will be approaching businesses for small amounts of sponsorship shortly.
- 7.10 Ward Cllr is arranging a joint meeting of Monkland and Eardisland Parish Councils to discuss highway safety on A44. Need to discuss possible dates and representatives.
- 7.11 PC has been approached to arrange a sign near the recreation ground on Church Lane, as some hall users are coming round the corner or up School Lane rather fast and concern has been raised with young children in the area and others crossing to the recreation ground.
Sign would have to be sited on private property not highway.
- 7.12 Balfour Beatty is now responsible for emptying all public waste bins. However, they will not empty dog waste bins. The options are: remove the bin and put a general waste bin there but this would have to be emptied through PC funding as BB would not take it on as an asset; or remove the bin altogether.
- 7.13 Defibrillator cabinet is due to be sited in the old telephone box and electrical work done free-of-charge by AC Electrics. But no earth feed in place, discussions taking place to resolve issue so installation can proceed. Clerk still talking to West Midlands Ambulance Service about the actual unit and training.
